PRAYER in WP (MD) No.21149/18:- Writ Petition filed under Article 226 of the Constitution of India seeking a Writ of Certiorarified Mandamus calling for the records relating to the impugned order of the respondent in Lr.No.23/2018/A1 dated 24.04.2018, quash the same and consequently direct the respondent to disburse the bill amount together with 12% GST payable by the petitioner in respect of contract work under Agreement No.148/2015-16 dated 26.02.2016 with the respondent.
