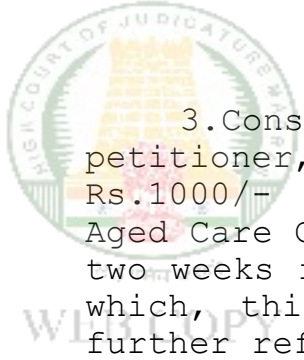
PRAYER IN CMA(MD) No.SR22442 of 2013
