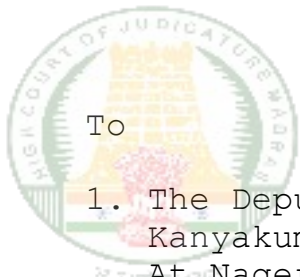
The learned counsel appearing for the appellant sought the permission of this Court to withdraw the Writ Appeal and he has also made an endorsement to that effect.
