ORDER : The Court Made the following order :-

The petitioner, who apprehends arrest at the hands of the respondent police in S.C.No.63 of 2013 on the file of the IV Additional District Judge, Tirunelveli for the offences punishable under Sections 147, 148, 341, 294(b), 307, 302 324, and 506(ii) r/w 149 I.P.C, seeks anticipatory bail.

2.The petitioner was absent during the trial in S.C.No.63 of 2013 on the file of the IV Additional District Judge, Tirunelveli. Therefore, Non-Bailable Warrant came to be issued on 10.08.2018.

3.The learned counsel appearing for the petitioner undertakes that the petitioner shall appear before the Court below regularly on all future hearing dates without fail.

4. Considering the undertaking given by the petitioner, the petitioner is directed to appear before the learned IV Additional District Judge, Tirunelveli within a period of two weeks from the date of receipt of a copy of this order and to file a petition to recall the NBW issued against him. The concerned Additional District Judge is directed to consider the same on merits and pass orders on the same day.



5. Accordingly, the Criminal Original Petition is disposed of.
