The writ petition is filed seeking for issuance of a Writ of Mandamus directing the first and second respondents to consider the petitioner's representation dated 07.05.2016.

2.According to the learned Senior Counsel appearing for the third respondent society, the prayer sought for in the writ petition has become infructuous, in view of the fact that the representation dated 07.05.2016 submitted by the petitioner herein had been considered and a proceedings was passed by the District Registrar of Co-operative Societies on 27.06.2016.
