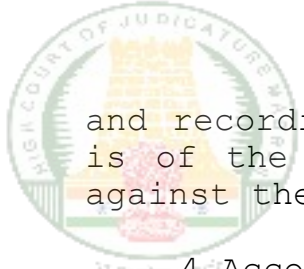
ORDER

This petition has been to quash the criminal proceedings in Crime No.280 of 2018 on the file of the first respondent police as against the petitioners herein.

2.Today, when the matter was taken up, the petitioners, the 2nd respondent, the learned counsel appearing for the petitioners and the learned counsel appearing for the second respondent are present and they have filed a memo of compromise stating that they have compromised the matter and the *de facto* complainant do not want to pursue the matter against the petitioners and she has no objection to quash the proceedings against the petitioners.
