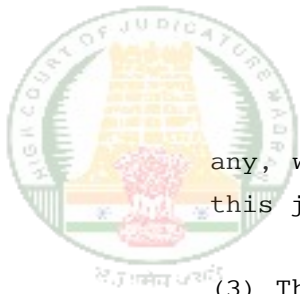

(1) That the award passed by the ADDITIONAL SUB JUDGE, THANJAVUR MACT, dated 21/07/2008 made in MCOP.14/2005 be and hereby is confirmed and the Civil Miscellaneous Appeal is dismissed.
