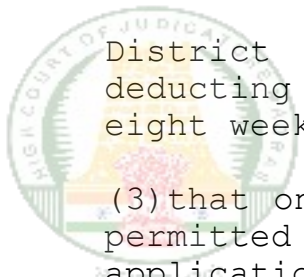

(1) That the Judgment and decree dated 31.08.2012 and made in M.C.O.P.No.460 of 2010 on the file of the District Judge, Motor Accident Claimas Tribunal, Karur be and hereby is confirmed and the Civil Miscellaneous Appeal is dismissed;

(2)that the third Respondent/herein be and hereby is directed to deposit the amounts awarded by the Tribunal together with interest to the credit of M.C.O.P. No.460 OF 2010 of the file of the

(4)that there be no order as to costs in this Civil Miscellaneous Appeal.
