Writ Petition is filed under Article 226 of the Constitution of India, praying this Court To issue a WRIT OF MANDAMUS, directing the Respondents 1 to 4 herein to initiate appropriate action both under the provisions of HR & CE Act and the provisions of Indian Penal Code against the 5th Respondent herein for committing the offence of misappropriation from the temple funds of Sri Nirathalamudaya Ayyanar Sonaiya Temple, Manamadurai as evident from the audit report of the Regional Audit Committee of Hindu Religious & Charitable Endowment dated 09-08-2010, forthwith and consequently direct the Respondents 1 and 2 herein to recover the misappropriated amount from the 5th Respondent belonging to Sri Nirathalamudaya Ayyanar Sonaiya Temple, Manamadurai.
