Prayer in WP(MD). 20936/ 2017 :

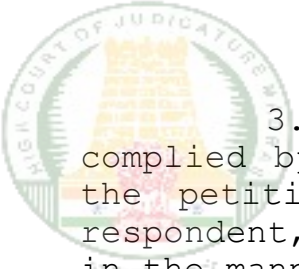
Writ Petition is filed under Article 226 of the Constitution of India, praying this Court to issue a writ of mandamus directing the respondent to consider the representations made by the petitioner dated 24.02.2017 and 07.03.2017 relating to issue patta to the petitioners landed property situated at SF.No.76, Plot No.1818, Sri Gangai Nagar, Poiyakaraipatti Village, Madurai East Taluk, Madurai to an extent of 1200 Sq.Ft. and SF.No.162/4B, Plot No.5 and 6, Arumbanur Pudur (Bit-2) Village, Y.Othakkadai, Madurai East Taluk, Madurai to an extent of 1856 Sq.Ft.

ORDER
