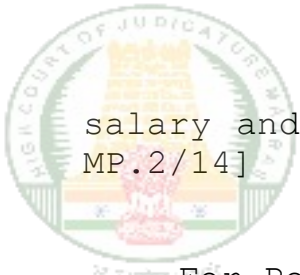

Prayer in WP(MD). 2323/ 2009 :

Writ Petition is filed under Article 226 of the Constitution of India, praying this Court to issue a Writ of Certiorified Mandamus, calling for the records relating to the impugned proceedings issued by the 1st respondent DEEO in Na.Ka.No.5211/Aa2/03 dated 29.07.2008 in so far as it places the petitioner on consolidated pay w.e.f. 14.06.2002 and regular time scale of pay only w.e.f.01.06.2006, quash the same and further direct the respondents to disburse forthwith the salary and allowances to the petitioner by placing in the time scale of pay w.e.f.14.06.2002 with all attendant benefits including arrears of
