O R D E R

This Criminal Original Petition has been filed to quash the proceedings in C.C.No.99 of 2012 on the file of the Judicial Magistrate Court, Theni.

2.Though the learned counsel for the petitioners raised several grounds for quashing the proceedings in C.C.No.99 of 2012, he submitted that it would suffice, if a direction is issued to the trial Court to complete the trial within a time limit that may be stipulated by this Court and also to permit the petitioners to raise all the grounds raised in this petition before the trial Court. However, he requested the appearance of the petitioners may be dispensed with before the Trial Court.



3.I have heard the learned Government Advocate (Crl.side) appearing for the first respondent, who has also conceded the request of the learned counsel for the petitioner.

4.In the light of the above said submissions of the learned counsel appearing for the petitioners, this Court, without going into the merits of the case, directs the learned Judicial Magistrate Court, Theni, to complete the trial in C.C.No.99 of 2012 within a period of four months from the date of receipt of a copy of this order.

5.With the above direction, this Criminal Original Petition is disposed of. Consequently, connected Miscellaneous Petitions are closed.
