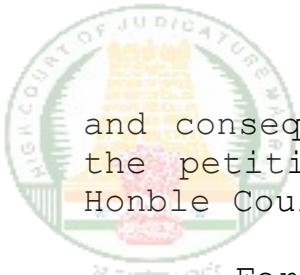
PRAYER: Petition filed under Section 11 of Contempt of Court Act, 1971, to initiate contempt proceedings against the Contemnors / Respondents and punish the Contemnors/ Respondents for the willful disobedience of the order of the Hon'ble Madurai Bench of Madras High Court in WMP(MD)No.6874 of 2016 in W.P.(MD)No.8569 of 2016 dated 28.04.2016.

Prayer in WMP(MD). 6874/ 2016 :

To pass an order of Interim Direction, directing the Respondents No.1 and 2 to reserve one post of Professor in Civil Engineering in any one of the Government Colleges of Engineering for the petitioner pending disposal of the above WP.

Prayer in WP(MD). 8569/ 2016 :

Writ Petition is filed under Article 226 of the Constitution of India, praying this Court To issue a Writ of Certiorarified Mandamus to call for the records pertaining to the Impugned order in G.O.(Ms) No.99, Higher Education (11) Department, dt.22.04.2016 on the file of the Respondent No.1 and quash the same as illegal to the extent of promoting the Respondents No.3 and 4 as Professors leaving out the Petitioner



and consequently to direct the Respondents No.1 and 2 to promote the petitioner as professor within the time stipulated by this Honble Court.
