To direct the Respondents 1 to 3 to release the arrears of monthly salary due to the Petitioners from February 2015 to till date immediately, pending disposal of the WP.



Prayer in WP(MD). 15603/ 2015 :

Writ Petition is filed under Article 226 of the Constitution of India, praying this Court To issue a Writ of Mandamus to Direct the 2nd Respondent to consider the proposal submitted by the Assistant Elementary Educational Officer, Rajapalayam in Na.Ka.No.981/A3/2015 dated 05.08.2015 and to order Direct Payment to the teachers of Harijan Primary School, Seithur Post, Rajapalayam Taluk, Virudhunagar District and to pay all other attendant and monetary benefits due to the petitioners with in a stipulated time may fixed by this Honble Court.

Prayer in SUB A(MD). 51/ 2016 :

To Direct the respondents 1 to 3 to release the arrears of monthly salary due to the petitioners immediately, pending disposal of the Cont P(MD)No.656 of 2016 and thus render justice.
