Prayer in WP(MD)No.21239/ 2015 :

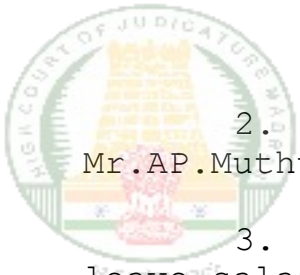
Writ Petition is filed under Article 226 of the Constitution of India, praying this Court to issue a Writ of Mandamus directing the Respondents to settle retirement benefits of the petitioners leave salary with interest at the rate of 18% per annum from the date of his retirement to till the date of settlement within the time that may be stipulated by this Hon'ble Court and further directing the respondents to settle the interest at the reate of 18% per annum for the belated payment of gratuity, the commuted value of pension, social security scheme arrears amount within the time.
