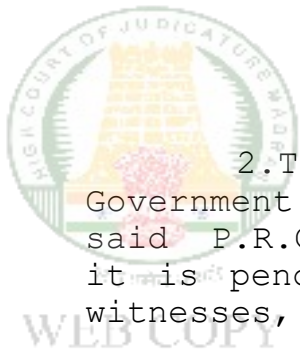

ORDER

The petitioners herein filed this petition to quash the entire proceedings in P.R.C.No.10 of 2013 as illegal.
