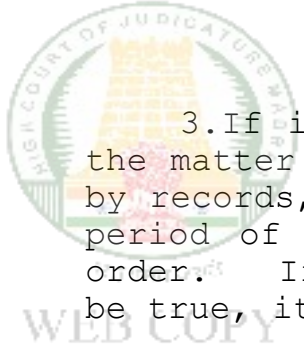

COMMON ORDER

The petitioner wants quashing of the impugned F.I.R. The offence made against the petitioner is under Section 420 IPC.

2.The learned counsel appearing for the petitioner would submit that the claim of the defacto complainants has been settled.



3.If it is so, the first respondent police shall enquire into the matter further. If the claim of the petitioner is established by records, he shall file A.D.R report. This shall be done within a period of two months from the date of receipt of a copy of this order. If the claim regarding the compromise does not turn out to be true, it is for the respondent police to file final report.

4.These Criminal Original Petitions are disposed of accordingly. Consequently, connected miscellaneous petitions are closed.
