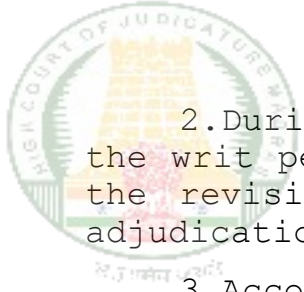

PRAYER: Writ Petition filed under Article 226 of the Constitution of India praying for issuance of a Writ of Certiorarified Mandamus, calling for the records relating to the proceedings of the 3rd respondent made in Roc.No.E7/19076/2011, dated 03.09.2011 and quash the same and consequently direct the respondents 2 & 3 to grant benefits to the retired employees in the cadre of Tahsildars, Block Development Officers, Inspectors of Police and Forest Rangers based on the G.O.Ms.No.71 Finance (Pay Cell) Department, dated 26.02.2011.

ORDER
