JUDGEMENT

[Judgement of the Court was delivered by K.RAVICHANDRABAABU, J]

It is represented by the learned counsel appearing for the appellant that connected writ appeals in W.A.(MD)Nos.522 and 523 of 2013, arising out of the same common order passed by the learned single Judge in W.P.(MD)No.1555 and 1572 of 2013, were dismissed by this Court, on 09.04.2018.
