According to the petitioner, he is the owner of the property in Survey Nos.149/4 and 150/2 at Kulathoor Village, Kulathoor Taluk, Pudukottai District. In the year 1997 during re survey the property has been wrongly sub-divided. In the above circumstances, the



petitioner filed an application to the first respondent to correct the mistake. Based on the application, the first respondent also directed the Tahsildar to file a report and the Tahsildar also filed a report on 15.06.2012, so far no action has been taken. Hence, the present writ petition has been filed.
