2.This being the factum of the case, no further adjudication is required in this writ petition. Accordingly, the writ petition stands closed. However, there shall be no order as to costs.

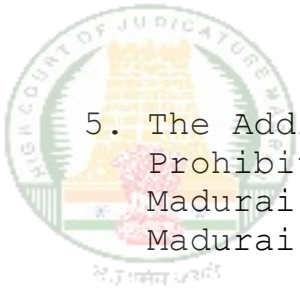
