However, during the pendency of the Writ Petition, the District Collector in proceeding, dated 10.12.2015 considered the grievance of the Petitioner and cancelled the order of punishment and sent proposals to the Commissioner for Revenue, for appropriate action. This being the factum, no further adjudication is required in this Writ Petition and the respondents are directed to consider the settlement of retirement and other benefits as early as possible.

3. With these observations, the Writ Petition stands disposed of. However, there shall be no order as to costs. Consequently, connected Miscellaneous Petition is closed.
