This Criminal Petition is filed by the petitioners under section 440 [2] read with section 482 Cr.P.C., seeking for modification of the orders dated 05/9/2017 passed in CrI.MP.No. 980 of 2017 by the VII-Additional Sessions Judge, Gudur, SPSR Nellore district, in Crime No. 135 of 2017 of Venkatagiri Police Station, registered for the offences punishable under sections 379, 353, 307, 120-B of I.P.C. and section 51 of Wild Life Protection Act, Section 20 [1] [c] [ii] [iii] [iv] [ix] [x] read with section 29 [1] [4] [a] 1 [a] [b] Section 3 of A.P. 5. As a sequel, miscellaneous petitions, if any pending in this Criminal Petition shall stand dismissed.

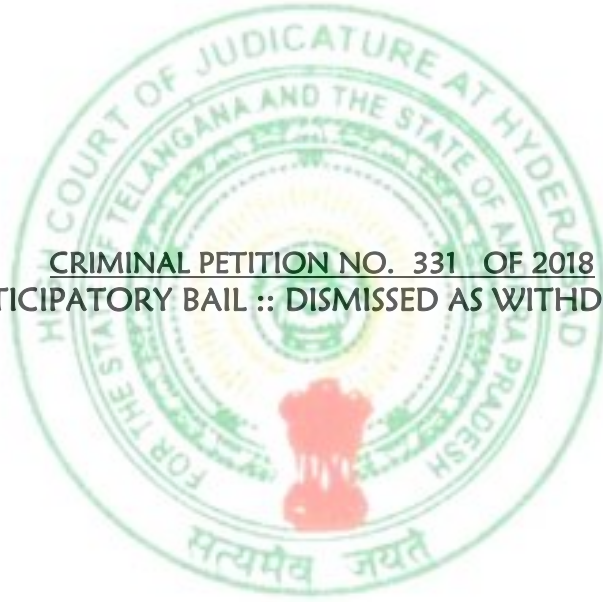
