Petition under Article 226 of the Constitution of India, praying that in the circumstances stated in the affidavit filed herein, the High Court may be pleased to issue an appropriate writ, order or direction more particularly one in the nature of Writ of Mandamus, and after calling for records pertaining to the impugned Lr.No. 686/HR A1/2015, dated 6-6-2015 rendered/passed by 1st respondent and the consequential Memo. No. CGM(HRD/GM (Adm. IR&L)/AS (Estt)/PO-Estt/547-D2/15, dated 10-6-2015 issued by the 2nd respondent as contrary to law and unconstitutional and consequently set aside/quash the same and hold that the petitioner is entitled to be treated as local as was accepted and recorded in service register as Local of Alwal and the same is evident from the appointment order vide Memo. DP/DMIT/E2/572/92, dated 4-9-1993 and read with letter of Superintending Engineer addressed to the Chief General Manager (HRD) TSSPDCL, Corporate Office, Mint Compound, Hyderabad vide Lr.No. SE/OP/MDK/PO/ADM/C1 /D.No.3804/ 14, dated 24-3-2015.

The petition coming on for hearing, upon perusing the petition and the affidavit filed herein and upon hearing the arguments of Sri D.Linga Rao, Advocate for the Petitioner and of the GP for Energy, (TG), for the

Respondent No.1, the Court made the following.
