Petition under Section 482 of Cr.P.C. praying that in the circumstances stated in the petition filed herein, the High Court may be pleased to relax the conditions imposed in the above criminal petition No. 4881 of 2018 by deleting the sentences that the petitioner shall not leave the head quarters and shall stay at Hyderabad and shall not leave Hyderabad without prior permission of the Magistrate concerned and further the petitioner shall report before the SHO on every alternative day between 05.00 pm and 10.00 pm for a period of two months or till filing the charge sheet whichever is earlier' from the order dated 01-05-2018 in the interest of justice, pending disposal of CRLP No.4881 of 2018, on the file of the High Court.

Petition under Section 438 of Cr.P.C. praying that in the circumstances stated in the petition filed herein, the High Court may be pleased to direct the Station House Officer, Shamshabad Police Station, to release the Petitioner on bail in the event of his arrest in connection with Cr.No. 108 of 2018 of Shamshabad Police Station, Cyberabad, Ranga Reddy District.

The petition coming on for hearing, upon perusing the Petition and the grounds filed in support thereof and the order of the High Court dated 01.05.2018 made herein and upon hearing the arguments of Sri C Damodar Reddy Advocate for the Petitioner and of Public Prosecutor(TG) for the respondent, the Court made the following.

ORDER

The condition in the order dated 01.05.2018 in CrI.P.No.4881 of 2018 of "the petitioner shall not leave the headquarters and shall stay at Hyderabad and shall not leave Hyderabad without prior permission of the Magistrate concerned' is modified as "the petitioner shall move the Headquarters without prior permission of the learned Magistrate concerned. So far as the present requirement to perform UMRAH to go to Soudi Arabia concerned, permitted for 8 (eight) weeks from today subject to execution of FDR for the amount of Rs.3,00,000/- (Rupees three lakhs only). In case, he fails to return within stipulated time, the entire amount will be forfeited as penalty under Section 53 IPC and he has to execute a bond without prejudice to other recourse.
