Petition under Article 226 of the Constitution of India praying that in the circumstances stated in the affidavit filed herein, the High Court may be pleased to issue a Writ, Order or Direction more particularly one in the nature of Writ of Mandamus declaring the action of the respondents in issuing Survey notice dated 20.06.2015 to survey the lands in Sy. No.128/1 of Kadivella Village, Yemmiganur Mandal, Kurnool District to change the extent and boundaries of the petitioner's land in Sy No.128/2 of Kadivella Village, Yemmiganur Mandal, Kurnool District by shifting Sub-Division Survey Numbers 128/1 and 128/2 of Kadivella Village, Yemmiganur Mandal, as being illegal, arbitrary and contrary to the provisions of Section 5 and 6 of the A.P.
