Petition under Article 226 of the Constitution of India praying that in the circumstances stated in the affidavit filed herein, the High Court may be pleased to issue an appropriate Writ or Order or Direction more particularly one in the nature of Writ of Mandamus declaring the action of the 2nd respondent at the instance of the 3rd respondent in canceling the allotment of seat for the petitioner in National Institute of Technology, Warangal vide Proceedings dated 11.07.2015 is illegal, arbitrary highhanded and violative of provisions of The Persons with Disabilities (Equal Opportunities, Protection of Rights and Full Participation) Act, 1995 and Rules made there under and also the guidelines issued in G.O.Ms.NO.31(Women Development, Child Welfare & Disabled Welfare (DW), dated 01.12.2009 and consequently direct the respondents 1 and 2 to allot the seat to the petitioner in National Institute of Technology, Warangal and admit. him continue till 27th July 2015 for four year course of Computer Science and Engineering by accepting the PWD certificate issued by the 4th respondent;
