The petition coming on for hearing, upon perusing the petition and the grounds filed in the CrI.P., and order of High Court dt. 29-08-2018 made in CrI.P No. 8622 of 2018 and upon hearing the arguments of Sri K. Rathanga Pani Reddy, Advocate for the Petitioners and of the Public Prosecutor(AP), for the Respondent/State, the Court made the following **ORDER:-**

"This application is filed by petitioners/A-1 to A-3 seeking relaxation of the conditions imposed in the order, dated 29.08.2018, in CrI.P.No.8622 of 2018.

Heard both sides. Perused the record.

The condition imposed on the petitioners/A-1 to A-3 to report before the Station House Officer concerned twice in a week i.e., on every Wednesday and Sunday between 10:00 A.M. and 11:00 A.M. till filing of the charge sheet and thereafter, once in a month on first Sunday till completion of trial/enquiry is modified as follows:

The petitioners/A-1 to A-3 shall attend before the Station House Officer concerned on every Sunday between 9:00 A.M. and 11:00 A.M. till filing of the charge sheet. There is no change in the other conditions.

Accordingly, this petition is ordered."
