Having regard to the submissions and the averments made in the affidavit filed in support of this petition, the condition with regard to the appearance of the petitioner/accused before the Station House Officer concerned on every Sunday till filing of the charge sheet and thereafter once in a month on 1st Sunday till completion of trial/enquiry between 10:00 AM and 11:00 AM, imposed by this Court, vide order, dated 06.09.2018, passed in Crl.P.No.9040 of 2018 is modified as follows:

"The petitioner/accused shall appear before the Station House Officer concerned on second and fourth Saturday of every month, for a period of two (02) months from today."

No change in the other conditions.

This petition is ordered accordingly.
