Pending disposal of CRLP No. 9197 of 2018, on the file of the High Court.

Petition under Section 438 of Cr.P.C., praying that in the circumstances stated in the grounds filed in the criminal petition, the High Court may be pleased to grant anticipatory bail to the petitioners/Accused No.2 and 3 in the event of their arrest in connection with the Cr.No.60/2018 of PS. CCS, DD, E Division, Hyderabad, pending enquiry and trial in the interest of Justice.

The petition coming on for hearing, upon perusing the Petition and the affidavit filed in support thereof and the order of the High Court dated 07-09-2019 made in CrI.P.No.9197 of 2018 and upon hearing the arguments of SRI MOHD MUZAFFER ULLAH KHAN Advocate for the Petitioners and the PUBLIC PROSECUTOR for the Respondent, the Court made the following

For the reasons stated in the accompanying affidavit, the condition that petitioners/accused Nos.2 and 3 shall report before the Station House Officer concerned on every Monday and Wednesday till filing of the charge sheet and thereafter once in a month on 1st Monday till completion of trial/enquiry between 5:00 and 6:00 PM, imposed by this Court vide order, dated 07.09.2018, in CrI.P.No.9197 of 2018 is hereby relaxed.

Accordingly, the application is allowed.
