Petition under Section 482 Cr.P.C. praying that in the circumstances stated in the affidavit filed in support of the petition, the High Court may be pleased to modify the conditions imposed on the petitioner in Crl.P.No.10120 of 2018 dated 03-10-2018, pending disposal of CRLP No.10120 of 2018, on the file of the High Court

The petition coming on for hearing, upon perusing the Petition and memo of grounds filed in Crl.P., and order of High Court dated 03.10.2018 made in Crl.P., order dated 02.04.2019 made in IA No.1 of 2019 and upon hearing the arguments of Sri P.Subash, Advocate for the Petitioner, and of Public Prosecutor for Respondent, the Court made the following

ORDER

This application is filed seeking to relax condition imposed by this Court on 03.10.2019 and modified on 02.04.2019 to appear before Station House Officer, concerned, once in a month on every first Sunday, between 5.00 PM to 06.00 PM till the end of trial, instead of 'on every Wednesday and Sunday till filing of the charge sheet and thereafter, once in a month on 1st Sunday till completion of trial/enquiry between 05.00 PM to 06.00 PM.

The petitioner is A.15 in Crime No.7 of 2015 pending on the file of Gadwal Police Station. The offences alleged against the petitioner are under Sections 420 and 109 IPC and Sections 4 and 6 read with (c) 3 of the Prize Chits and Money Circulation Scheme (Banning Act), 1978 and Section 58(3) of RBI Act, 1934 and 156(3) of Cr.P.C.

Learned Public Prosecutor, on instructions would submit that the investigation is still pending and charge sheet has to be filed. He further submits that there is no allegation against the petitioner with regard to the allegation of violation of any of the conditions imposed by this Court.

Considering the said aspects, this application is allowed relaxing the condition to appear before Station House Officer, concerned, once in a month on every first Sunday, between 5.00 PM to 06.00 PM till the end of trial, instead of 'on every Wednesday and Sunday till filing of the charge sheet and thereafter, once in a month on 1st Sunday till completion of trial/enquiry between 05.00 PM to 06.00 PM. However, it is made clear that other conditions imposed in the order remain unaltered. The petitioner shall cooperate with the Investigating Officer by appearing before him as and when his presence is required.
