The Court made the following ORDER:

"This Criminal Petition, under Section 439 of the Code of Criminal Procedure, 1973, is filed by the petitioner/A.3, for grant of bail in Crime No.606 of 2018 of Gachibowli Police Station, Cyberabad Commissionerate, registered for the offences punishable under Section 25(1B)(b) of Arms Act, 1959 and Section 20(b)(ii)(b) of the Narcotic Drugs and Psychotropic Substances Act, 1985.

2. Heard the learned counsel for the petitioner/A.3, the learned Additional Public Prosecutor representing the respondent-State and perused the record.

3. As per the material placed on record, no ganja was seized from the possession of the petitioner/A.3. Further, two kilograms of ganja is alleged to have been seized from the possession of A.1 and A.2 in this crime on 29.07.2018. The learned Additional Public Prosecutor contended that the petitioner/A.3 is a supplier of ganja and he is involved in other criminal cases. It appears that this petitioner/A.3 is made an accused, pursuant to the confession made by the other accused in this crime. Under these circumstances, this Court is inclined to grant bail to the petitioner/A.3 on some conditions.

4. Accordingly, the petitioner/A.3 is ordered to be released on bail on his executing a personal bond for a sum of Rs.10,000/- (Rupees ten thousand only) with two sureties in a like sum each to the satisfaction of the learned XII Metropolitan Magistrate-cum-Special

Judicial Magistrate of First Class for Prohibition & Excise Cases at L.B.Nagar, Ranga Reddy District. After release on bail, the petitioner/A.3 shall report before the Station House Officer, Gachibowli Police Station, Cyberabad Commissionerate, on every Sunday between 09:00 AM and 10:00 AM, till filing of the charge-sheet.

5. The Criminal Petition is, accordingly, allowed.

Miscellaneous petitions, if any, pending in this Criminal Petition, shall stand closed."
