Main Cases:-

This judgment shall dispose of aforementioned two petitions as the order assailed in both the petitions is common order dated 08.02.2018 passed by Additional Chief Judicial Magistrate, Patiala, vide which the wife (Anjali) was held entitled of maintenance @ ₹15000/- per month from 21.01.2014 only at one place of her choice.

Learned counsel for the parties states that they have entered into a compromise and in pursuance of the compromise, the parties have filed a petition under Section 13B of the Hindu Marriage Act, 1955.

In view of the compromise reached between the parties, this Court feels that the intended purpose of filing the present petitions has been achieved.
