ANUPINDER SINGH GREWAL, J. (ORAL)

The petitioners are seeking quashing of the cross version case registered vide DDR No.22 dated 25.02.2018, under Sections 324, 323, 34 IPC, (Section 326 IPC added later on) at Police Station Bajakhana, District Faridkot (Annexure P-1) in FIR No.19 dated 25.02.2018, under Sections 295A, 323, 34 IPC, registered at Police Station Bajakhana, District Faridkot (Annexure P-2) on the basis of compromise dated 24.03.2018 (Annexure P-3) arrived at between the parties.

Learned counsel for the petitioners contends that the DDR is an outcome of some misunderstanding between the parties, which has now been resolved and the matter has been compromised.

A Coordinate Bench of this Court by the order dated 03.04.2018 had directed the parties to appear before the trial

Court to record the statements of the parties with regard to genuineness of the compromise and send a report to this Court. The report of JMIC, Faridkot, dated 21.04.2018 has been received, wherein it is stated that in pursuance to the order of this Court, the statements of the parties were recorded which indicates that the compromise is genuine and without any coercion or undue influence.

The DDR is an outcome of some misunderstanding, which has now been resolved and the matter has been compromised.

In view of the mandate of the Hon'ble Supreme Court in the case of ***Narinder Singh and others Vs. State of Punjab and another, (2014) 6 SCC 466***, no useful purpose will be served by continuing the criminal proceedings. Therefore, the petition is allowed and DDR No.22 dated 25.02.2018, under Sections 324, 323, 34 IPC, (Section 326 IPC added later on) at Police Station Bajakhana, District Faridkot (Annexure P-1) in FIR No.19 dated 25.02.2018, under Sections 295A, 323, 34 IPC, registered at Police Station Bajakhana, District Faridkot (Annexure P-2) and all subsequent proceedings arising therefrom, are hereby quashed qua the petitioner(s).
