The instant petition is for quashing of FIR No. 7 dated 10.02.2018 registered under Sections 451, 363, 366, 511, 506 IPC, Police Station Boha, District Mansa and the consequent proceedings arising out of the same, on the basis of written compromise arrived at between the parties.

Report has been received from the trial Court after statements of the parties were recorded regarding the compromise. The trial Court has reported that the compromise is voluntary and without any pressure or coercion. The trial Court has also sent statements of parties in original.

Learned counsel for the State on instructions submits that petitioners are the only accused and respondents no.2 & 3 are the only aggrieved persons in this FIR.

State of Punjab and others (2012) 10 SCC 303**, the instant petition is allowed and the aforesaid FIR and all consequent proceedings conducted on the basis thereof are quashed qua the petitioners.

Needless to say that parties shall remain bound by the terms of compromise and their statements made in the Court below.
