The instant petition is for quashing of FIR No.19 dated 08.03.2017 registered under Sections 354A(1)(iv) of IPC and Sections 67 & 67-A of the Information Technology (Amendment) Act, 2008, Police Station Nurmehal, District Jalandhar Rural and the consequent proceedings arising out of the same, on the basis of written compromise arrived at between the parties.

Report has been received from the trial Court after statements of the parties were recorded regarding the compromise. The trial Court has reported that the compromise is voluntary and without any pressure or coercion. The trial Court has also sent statements of parties in original and copy the compromise Ex.P-1.
