Prayer in the instant petition under Section 482 Cr.P.C. has been made for quashing FIR No.0047, dated 26.02.2018 (Annexure P-1), registered under Section 392 IPC at Police Station Chandimandir, District Panchkula and all subsequent proceedings arising therefrom, on the basis of compromise (Annexure P-2).

Pursuant to order dated 13.07.2018 of this Court, the parties appeared before the trial Court/Illaq Magistrate on 14.08.2018 to get their statements recorded. Learned Additional Chief Judicial Magistrate, Panchkula, has submitted his report vide letter bearing No.1690, dated 16.08.2018 duly forwarded by learned District and Sessions Judge, Panchkula, vide Endst. No.3083-J, dated 16.08.2018.

According to the report, learned Additional Chief Judicial Magistrate, Panchkula, is satisfied that compromise entered into between the parties is genuine, voluntary, without any coercion or undue influence

and their free will.

Considering the report of learned Additional Chief Judicial Magistrate, Panchkula, dated 16.08.2018 and the fact that the compromise will bring peace and harmony in relations between the parties, aforesaid FIR No.0047, dated 26.02.2018(Annexure P-1) and all subsequent proceedings arising therefrom, are quashed, subject to payment of costs of ₹10,000/-, out of which ₹8,000/- shall be deposited with the following account:-
