The instant petition is for quashing of FIR No.0118 dated 10.06.2016 registered under Sections 354, 457 of IPC, Police Station Dakha, District Ludhiana Rural and the consequent proceedings arising out of the same, on the basis of written compromise arrived at between the parties.

Report has been received from the trial Court after statements of the parties were recorded regarding the compromise. The trial Court has reported that the compromise is voluntary and without any pressure or coercion. The trial Court has also sent copy of statements of parties.

Learned counsel for the State on instructions submits that petitioner is the only accused and respondent nos.2 & 3 are the only aggrieved persons in this FIR.

State of Punjab and others (2012) 10 SCC 303**, the instant petition is allowed and the aforesaid FIR and all consequent proceedings conducted on the basis thereof are quashed qua the petitioners.
