Criminal Misc. No. M- 19845 of 2018

This petition has been filed by the petitioner seeking protection
of her life and liberty at the hands of respondents No. 5 to 7 as it was
averred that she was being harassed due to pendency of FIR No. 0054 dated
26.04.2018 under Sections 323, 34, 341, 365, 379A, 506 IPC read with
Section 25 of Arms Act, 1959 registered at Police Station Women Narnaul,
District Mahendergarh.

Following order was passed on the last date of hearing:-

“ Status report dated 12.05.2018, by way of affidavit of
Kamal Deep Goyal, HPS, Superintendent of Police,
Mahendergarh, filed in Court today is taken on record subject

to just exceptions.

Petitioner, duly identified by her counsel is present in Court.

Though, notice was not issued to respondents no.6 and 7, they are present in Court, today. Respondent no.6, father of the petitioner, present in Court, duly identified by his counsel, states that he has no objection whatsoever to the petitioner living her life in the manner she wishes. He shall not compel her to come back to her parental home or to take any step which is not in consonance with her wishes.

Learned counsel for respondents no.6 and 7 submits that the said respondents have never interfered in the life of the petitioner in any manner, neither shall they do so in future. No threat was ever extended to her or her Advocate-Harjit Yadav.

Respondent no.5, who is the Investigating Officer in FIR No.0054 dated 26.04.2018, is present in Court. She states that there is no question of any harassment being meted out to the petitioner at the hands of the authorities.

Learned counsel for the State submits that in case the petitioner still feels any kind of threat to her life, immediate action shall be taken by respondent no.2 in this regard if the petitioner approaches him. It is further submitted that security was also provided to her counsel namely Harjit Yadav though at this time there is no perception of any threat qua him.

On request of learned counsel for the parties, adjourned to 01.06.2018.”

Learned counsel for the petitioner submits that as of now the petitioner does not face any threat to her life and liberty.

Learned counsel for the respondents No. 6 and 7 reiterate that there is no question of any interference in the life of the petitioner. It is stated that they do not have anything to do with the petitioner and would, thus, not take any steps which are not in consonance with the wishes of the petitioner.

Respondent No. 5, the Investigating Officer in this case, clearly stated on 14.05.2018 that there is no question of any harassment to the petitioner.

Learned counsel for the State reiterates the statement made on behalf of State on 14.05.2018.

Keeping in view the facts and circumstances as above, no further orders are called for.

Needless to say, in case, the petitioner approaches respondent No. 2, expressing any fresh apprehension to her life and liberty, the same shall be looked into and necessary action, if any/as may be required be taken in accordance with law.

It is clarified that none of the observations in this order shall have any bearing on the matter/matters which is/are subject of FIR No. 157 dated 06.04.2018 under Section 346 IPC registered at Police Station City Narnaul or FIR No. 54 dated 26.04.2018 under Sections 323, 34, 341, 365, 379A, 506 IPC, Section 25 of Arms Act registered at Police Station Women Police Station, Narnaul.

Present petition is, accordingly, disposed of.
