RAMENDRA JAIN, J. (ORAL)

1. Through this petition under Section 482 Cr.P.C., prayer has been made for quashing FIR No. 137 dated 30.3.2016 (Annexure P-1) registered under Sections 406, 409, 420, 468 read with Section 120-B IPC at Police Station DLF, Phase II, Gurugram, and all subsequent proceedings arising therefrom, on the basis of compromise dated 10.1.2018 (Annexure P-2), effected between the parties.

2. Vide order dated 12.7.2018, the parties were directed to appear before the trial Court/Illaq Magistrate, before 31.8.2018, to get their statements recorded for compromise with a direction to the trial Court/Illaq Magistrate, to furnish a report qua veracity of the compromise.

3. Consequently, parties appeared before the Chief Judicial Magistrate, Gurugram and got recorded their statements qua compromise on

13.08.2018. Report from the learned Chief Judicial Magistrate, Gurugram vide letter No. 500 dated 17.8.2018 duly forwarded by the District and Sessions Judge, Gurugram vide letter No. 1783 Dated 23.8.2018 has been received. According to the report of learned Chief Judicial Magistrate, Gurugram, the parties have voluntarily entered into the compromise between themselves and have settled the matter amicably.

4. In view of the totality of the facts and circumstances and considering the fact that the compromise will bring harmony and peace in relations between the parties, this petition is allowed and the aforesaid, FIR No. 137 dated 30.3.2016 (Annexure P-1) and all subsequent proceedings arising therefrom, qua the petitioners are quashed, subject to payment of costs of Rs.10,000/-, out of which Rs.8,000/- shall be deposited with the following account:-
