Prayer in the instant petition under Section 482 Cr.P.C. has been made for quashing FIR No.119, dated 19.06.2010 (Annexure P-1), registered under Sections 323/324/326/341/148/149/506 IPC at Police Station Adampur, District Jalandhar, and all subsequent proceedings arising therefrom, on the basis of compromise dated 26.03.2018 (Annexure P-5).

Pursuant to order dated 30.05.2018 of this Court, the parties appeared before the trial Court/Illaq Magistrate on 18.07.2018 to get their statements recorded. Learned Judicial Magistrate, Ist Class, Jalandhar, has submitted her report vide letter bearing No.242, dated 25.07.2018 duly forwarded by learned District and Sessions Judge, Jalandhar, vide Endst. No.1851/G/JRK, dated 26.07.2018.

According to the report, learned Judicial Magistrate, Ist Class, Jalandhar, is satisfied that compromise entered into between the parties is

genuine, voluntary, without any coercion or undue influence with their free

will.

Considering the report of learned Judicial Magistrate, Ist Class, Jalandhar, dated 25.07.2018 and the fact that the compromise will bring peace and harmony in relations between the parties, aforesaid FIR No.119, dated 19.06.2010 (Annexure P-1) and all subsequent proceedings arising therefrom, are quashed, subject to payment of costs of ₹10,000/-, out of which ₹8,000/- shall be deposited with the following account:-
