ARVIND SINGH SANGWAN, J.(ORAL)

Prayer in this petition is for protection of lives and liberty of the petitioners on account of threats being faced by them for initiating criminal action/complaints against various high ranking officers. It is further prayed that directions be issued to respondent No.2 to take legal action on the complaint/representation (Annexure P-4) submitted by the petitioners.

Brief facts of the case are that the petitioners have created a self styled NGO ("Dalit Foundation Organization") and Foundation started campaign against corruption in the government officials including the District Courts at Sri Muktsar Sahib. It is further stated in the petition that the petitioners have given various representations (Annexures P-2, P-3 and P-5) to Hon'ble Chief Justice of this Court as well as to the Hon'ble Chief Justice of India highlighting that certain judges and employees are

indulged in corrupt practice.

Counsel for the petitioners submits that petitioners have also given the complaint (Annexure P-4) to Senior Superintendent of Police, Sri Muktsar Sahib on 03.05.2018 for providing protection to them as petitioners have given complaints against high ranking officials. Counsel further prayed that necessary directions be issued to Senior Superintendent of Police to look into the grievance of the petitioners and provide protection to the lives and liberty of the petitioners.

After hearing counsel for the petitioners and going through the complaints (Annexures P-2, P-3 and P-5), I find that vague allegations have been levelled against some of the judges posted at Sri Muktsar Sahib as well as employees of the Court without therebeing any supporting substantive evidence or document. All these complaints are addressed under the signatures of the petitioners whose credibility to conduct such type of campaign as alleged in the petition is not trustworthy as nothing is mentioned in the petition that the petitioners except for filing complaint have done any social work for good cause.

Perusal of the aforesaid complaints given to the higher authorities also show that the allegations levelled with regard to demand of money for providing jobs to various persons are without any affidavit, document or any proof by such persons or victims and only bald allegations are levelled by petitioners themselves.

In view of the above, I find that no grounds for

providing protection to lives and liberty of the petitioners are made out as except for filing the complaints before the higher authorities by levelling allegations of corruption, without therebing any supporting document or evidence, the petitioners do not get any right to seek any such protection, as it is nothing but an act of procuring publicity.

Petition stands dismissed.
