Prayer in the instant petition under Section 482 Cr.P.C. has been made for quashing FIR No.16, dated 10.03.2015 (Annexure P-1), registered under Sections 323/342/506/34 IPC at Police Station Singh Bhagwantpura, District Rupnagar and all subsequent proceedings arising therefrom, on the basis of compromise (Annexure P-2).

Pursuant to order dated 09.07.2018 of this Court, the parties appeared before the trial Court/Illaq Magistrate on 26.07.2018 to get their statements recorded. Learned Civil Judge (Jr. Division)-cum-JMIC, Rupnagar, has submitted her report vide letter bearing No.362, dated 04.08.2018 duly forwarded by learned District and Sessions Judge, Rupnagar, vide Endst. No.8752, dated 04.08.2018.

According to the report, learned Civil Judge (Jr. Division)-cum-JMIC, Rupnagar, is satisfied that compromise entered into between the parties is genuine, voluntary, without any coercion or undue influence with

Considering the report of learned Civil Judge (Jr. Division)-cum-JMIC, Rupnagar, dated 04.08.2018 and the fact that the compromise will bring peace and harmony in relations between the parties, aforesaid FIR No.16, dated 10.03.2015 (Annexure P-1) and all subsequent proceedings arising therefrom, are quashed, subject to payment of costs of ₹10,000/-, out of which ₹8,000/- shall be deposited with the following account:-
