Prayer in this petition is for quashing of FIR No.21 dated 02.03.2016, under Sections 498-A, 313, 406, 34 IPC, registered at Police Station Sadar Malout, District Sri Mukitsar Sahib, along with all other consequential proceedings arising therefrom on the basis of a compromise dated 14.07.2017 (Annexure P-2) arrived at between the parties.

It is submitted that the above-said FIR was registered at the instance of respondent No.2 due to matrimonial discord with her husband-petitioner no.1. Learned counsel for the petitioners and respondent no.2 submit that petition under Section 13-B of the Hindu Marriage Act, 1955, has since been allowed on 06.02.2018. The entire settled amount has since

been received by respondent no.2, who has no objection to the quashing of the aforementioned FIR against the petitioners. It is thus prayed that this petition be allowed.

This Court on 02.04.2018 directed the parties to appear before the learned trial court for recording of their statements in respect to the above-mentioned compromise. Learned trial court was directed to submit a report regarding the genuineness of the compromise, as to whether it has been arrived at out of the free will and volition of the parties without any coercion, fear or undue influence. Learned trial court was also directed to intimate whether the petitioners are absconding/proclaimed offenders and whether any other case is pending against them. Information was sought as to whether all affected persons are a party to the settlement.

Pursuant to order dated 02.04.2018, the parties appeared before the learned Sessions Judge, on 23.04.2018. Respondent No.2 stated that the matter has been amicably resolved by her with all the petitioners out of her own free will, without any pressure, undue influence or coercion. Respondent no.2 further stated that decree of divorce has been granted on 06.02.2018 and she does not wish to proceed against the accused-petitioners. It is further stated that she has no objection to the quashing of the aforementioned FIR against all the petitioners. Joint statement of all the petitioners in respect to the settlement were recorded.

As per report dated 26.04.2018, received from the learned Sessions Judge, Sri Muktsar Sahib, satisfaction is expressed that the compromise between the parties is genuine, voluntarily arrived at out of the free will of the parties, without any pressure or coercion. Petitioners

are not reported to be proclaimed offenders.

Learned counsel for respondent No.2 affirms and verifies the factum of settlement between the parties. It is reiterated that respondent No.2 has no objection to the quashing of the above-mentioned FIR against all the petitioners.

Learned counsel for the State has not raised any serious objection to the quashing of this FIR on the basis of a settlement arrived at between the parties.

In ***Kulwinder Singh and others versus State of Punjab and another*** 2007 (3) R.C.R. (Criminal) 1052, a five member Bench of this Court has observed as under:-

“The compromise, in a modern society, is the sine qua non of harmony and orderly behaviour. It is the soul of justice and if the power under Section 482 of the Criminal Procedure Code is used to enhance such a compromise which, in turn, enhances the social amity and reduces friction, then it truly is “finest hour of justice”.

The Hon'ble Supreme Court in ***B.S.Joshi and others v. State of Haryana, 2003(4) SCC 675*** has observed that it becomes the duty of the Court to encourage genuine settlements of matrimonial disputes.

Keeping in view the facts and circumstances of this case, it would be in the interest of justice to quash the above-said FIR as no useful purpose would be served by continuance of the present proceedings. It will merely lead to wastage of precious time of the court and would be an exercise in futility.

This petition is, thus, allowed and FIR No.21 dated 02.03.2016, under Sections 498-A, 313, 406, 34 IPC, registered at Police

Station Sadar Malout, District Sri Mukitsar Sahib, along with all consequential proceedings are, hereby, quashed.
