Prayer in the instant petition under Section 482 Cr.P.C. has been made for quashing of complaint No.579 of 2017, dated 01.04.2017 (Annexure P-1), registration No.25 of 2017 under Sections 323/506/341 IPC and Section 3 of the Scheduled Castes and the Scheduled Tribes (Prevention of Atrocities) Act, pending in the Court of learned Additional Chief Judicial Magistrate, Barnala, and all subsequent proceedings arising therefrom, on the basis of compromise dated 07.07.2018 (Annexure P-3).

Pursuant to order dated 13.07.2018 of this Court, the parties appeared before the trial Court/Illaq Magistrate on 26.07.2018 to get their statements recorded. Learned Judicial Magistrate, Ist Class, Barnala, has submitted his report vide letter bearing No.685, dated 03.08.2018 duly forwarded by learned District and Sessions Judge, Barnala, vide Endst. No.4634/EB, dated 04.08.2018.

According to the report, learned Judicial Magistrate, Ist Class, Barnala, is satisfied that compromise entered into between the parties is

genuine, voluntary, without any coercion or undue influence with their free

will.

Considering the report of learned learned Judicial Magistrate, Ist Class, Barnala, dated 03.08.2018 and the fact that the compromise will bring peace and harmony in relations between the parties, aforesaid complaint No.579 of 2017, dated 01.04.2017 (Annexure P-1) and all subsequent proceedings arising therefrom, are quashed, subject to payment of costs of ₹10,000/-, out of which ₹8,000/- shall be deposited with the following account:-
