In the instant petition, petitioners are seeking quashing of DDR No. 37(A) dated 05.04.2013 under Sections 325, 323, 148, 149 IPC, registered at Police Station Chabbewal, District Hoshiarpur which has been registered as a cross case in FIR No.32 dated 30.03.2013 under Sections 324, 323, 34 IPC, Police Station Chabbewal, District Hoshiarpur and consequential proceedings arising therefrom on the basis of compromise dated 16.04.2017 (Annexure P-3) arrived at between the parties.

2. Learned counsel for the petitioners contended that present DDR is cross case in FIR No.32 dated 30.03.2013. Now the matter has been resolved and sought for quashing of DDR in view of compromise Annexure P-3 and in the connected case i.e. CRM-M-27940-2017.

3. This Court vide order dated 21.04.2018 in connected case had

directed the parties to appear before the Illaqa Magistrate/trial Court for recording their statements with regard to veracity of the compromise. The Addl. Chief Judicial Magistrate, Hoshiarpur has sent her report dated 24.07.2018 wherein it is stated that in pursuance to the order of this Court, statements of the parties were recorded and compromise has been effected without any fear or undue influence.

4. In view of the law laid down in “*Anita Maria Dias and another versus State of Maharashtra and another*” (2018) 3 SCC 290, no useful purpose would be served by continuing the criminal proceedings. Therefore, the petition is allowed and DDR No. 37(A) dated 05.04.2013 under Sections 325, 323, 148, 149 IPC, registered at Police Station Chabbewal, District Hoshiarpur which has been registered as a cross case in FIR No.32 dated 30.03.2013 under Sections 324, 323, 34 IPC, Police Station Chabbewal, District Hoshiarpur and all consequential proceedings arising therefrom, are hereby quashed qua the petitioners subject to payment of litigation cost of Rs.3000/- by each of the petitioner to State of Punjab. Cost shall be remitted in the District Treasury, District Hoshiarpur, State of Punjab within a period of 3 months from today.
