KULDIP SINGH J. (ORAL)

Heard.

Present application filed under Section 438 of the Code of Criminal Procedure for grant of anticipatory bail to the petitioners in case FIR No. 0067 dated 19.5.2018 under Sections 323/326/148/149 IPC, registered at Police Station Shambu, District Patiala.

Learned State counsel submits that Jatinder Singh @ Sahil has joined the investigation. She also states that applicant-petitioner No. 1 has been thoroughly interrogated and no recovery is to be effected from Jatinder Singh @ Sahil. Therefore, interim bail granted to Jatinder Singh @ Sahil vide order dated 19.7.2018 is made absolute.

So far as the role of Parminder Singh @ Bunty is concerned, it comes out that on 18.5.2018, Jaswinder Singh cousin brother of Jasvir Singh @ Mithu complained to be beaten up by Parminder Singh @ Bunty.

When the complainant intervened, Paramjit Singh having *kirtch*, Lakhwinder Singh having *danda*, Parminder Singh @ Bunty having *hockey*, Prince son of Kuldip Singh having *danda* and Jatinder Singh @ Sahil empty handed reached at the spot and on the exhortation raised by Palwinder Singh who after taking the *kirch* from Paramjit Singh, who held Jasvir Singh-complainant, cut the left ear with the *kirch*. Lakhwinder Singh gave *danda* blow on the left eye and Parminder Singh @ Bunty gave a *hockey* blow on the head of Jaswinder Singh. Large number of people gathered at the spot and the occurrence took place at about 9.00 P.M.

So far as Jatinder Singh @ Sahil is concerned, no injury is attributed to him, therefore, he has been granted anticipatory bail vide order dated 19.7.2018, which has been made absolute today.

So far as Parminder Singh @ Bunty is concerned, he gave *hockey* blow on the head of the Jaswinder Singh. In furtherance of common intention of all the co-accused, considering the manner of the crime, there is no ground to grant bail to the Parminder Singh @ Bunty.

Dismissed.
