Prayer in the instant petition under Section 482 Cr.P.C. has been made for quashing FIR No.128, dated 16.05.2018 (Annexure P-1), registered under Sections 323/341/458/427 IPC, at Police Station Kotwali, District Patiala and all subsequent proceedings arising therefrom, on the basis of compromise dated 13.07.2018 (Annexure P-2).

Pursuant to order dated 17.08.2018 of this Court, the parties appeared before the trial Court/Illaq Magistrate on 28.08.2018 to get their statements recorded. Learned Chief Judicial Magistrate, Patiala, has submitted her report vide letter bearing No.151, dated 05.09.2018 duly forwarded by learned District and Sessions Judge, Patiala, vide Endst. No.4368, dated 06.09.2018.

According to the report, learned Chief Judicial Magistrate, Patiala, is satisfied that compromise entered into between the parties is genuine, voluntary, without any coercion or undue influence with their free

Considering the report of learned Chief Judicial Magistrate, Patiala, dated 05.09.2018 and the fact that the compromise will bring peace and harmony in relations between the parties, aforesaid FIR No.128, dated 16.05.2018 (Annexure P-1) and all subsequent proceedings arising therefrom, are quashed, subject to payment of costs of ₹10,000/-, out of which ₹8,000/- shall be deposited with the following account:-
