Prayer in the instant petition under Section 482 Cr.P.C. has been made for quashing FIR No.55, dated 07.04.2010 (Annexure P-1), registered under Sections 323/324/148/149 IPC and later on added Sections 325/506/427 IPC, at Police Station Sadar Nabha, District Patiala, in cross versions recorded by respondent No.2 and convicted under Sections 325/323/324 read with Section 148/149 IPC and all subsequent proceedings arising therefrom, on the basis of compromise (Annexure P-2).

Pursuant to order dated 31.07.2018 of this Court, the parties appeared before the trial Court/Illaq Magistrate on 10.08.2018 to get their statements recorded. Learned Sub Divisional Judicial Magistrate, Nabha, has submitted his report vide letter bearing No.873, dated 17.08.2018 duly forwarded by learned District and Sessions Judge, Patiala, vide Endst. No.4085, dated 21.08.2018.

According to the report, learned Sub Divisional Judicial Magistrate, Nabha, is satisfied that compromise entered into between the

parties is genuine, voluntary, without any coercion or undue influence with

their free will.

Considering the report of learned Sub Divisional Judicial Magistrate, Nabha, dated 17.08.2018 and the fact that the compromise will bring peace and harmony in relations between the parties, aforesaid IR No.55, dated 07.04.2010 (Annexure P-1), registered under Sections 323/324/148/149 IPC and later on added Sections 325/506/427 IPC, at Police Station Sadar Nabha, District Patiala, in cross versions recorded by respondent No.2 and all subsequent proceedings arising therefrom, are quashed, subject to payment of costs of ₹10,000/-, out of which ₹8,000/- shall be deposited with the following account:-
