Petitioners have preferred the instant petition under Section 482 Cr.P.C. for quashing of impugned order dated 10.08.2017, passed by the Addl. Sessions Judge, Gurugram, whereby the application dated 31.07.2017, filed by them seeking permission to furnish the combined sureties or personal bonds on their behalf in all the 54 FIRs has been dismissed.

In compliance of order dated 28.02.2018, passed by this Court, the report of Tehsildar has already been received.

As per said report, the value of the property is Rs.9,00,00,000/- (Rupees Nine crore). However, in para No.4 of the award dated 29.07.2017, the value of the property of village Naurangpur has been assessed as Rs.3,20,92,565/- per acre. The property of Sanjay son of Kartar Singh is also in Naurangpur. The value of the property is not below the

total amount of sureties in all 54 cases, details whereof have been given below.

In view of above, the instant petition stands allowed. Both petitioners Rajesh Kumar and Yogesh sons of Sh.Harpal Singh are allowed to give surety of the land bearing Khewat No.131 and 135, situated in the village Naurangpur. However, surety Sanjay son of Kartar Singh will submit an affidavit that he will not sell off the said property during the pendency of the cases. Each surety amount shall be a charge on the said land.

The State counsel is also directed not to register any document regarding the said property without the permission of the trial Court in each of the following cases:-
